## SPECIFIC TERMS AND CONDITIONS FOR THE PURCHASERS OF THE COMMANDER BUNDLE

#### A. INTRODUCTION

- A.1. WALL BOX CHARGERS, S.L. (hereinafter "WALLBOX") is a company with Tax Id. Number B66542903, registered office at Paseo Castellana, nº 95, (28046) Madrid, Spain, and email address <u>service@wallbox.com</u>, duly registered in the Companies Register of Barcelona, Volume 44872, Folio 59, General Section, Sheet no. B-469977, Inscription 1.
- A.2. WALLBOX is the proprietor of a service aimed at operating smart devices for charging electric vehicles, which includes, among others, the devices belonging to the 'COMMANDER' family and any other charging device (hereinafter the 'Devices'), the smart electric vehicle charging service via Devices converted into charging stations, and their energy management and monitoring by means of the 'Wallbox' mobile application (hereinafter the 'Application'), and the <u>mywallbox.com</u> portal (hereinafter the 'Portal').
- A.3. The COMMANDER Bundle is a pack of particular elements, exclusively addressed to companies, that WALLBOX offers to its clients, and which contains: a COMMANDER, a Vodafone 3G or 4G SIM card and a myWallbox Business Subscription Plan to the Application (hereinafter the **'COMMANDER Bundle'**).
- A.4. These Specific Terms and Conditions for the Purchasers of the COMMANDER Bundle, jointly with the general terms and conditions of WALLBOX, and the specific terms and conditions of the business subscription plan, are binding on any Client who purchases the COMMANDER Bundle. Purchasing the COMMANDER Bundle shall imply the acceptance by the Client of these Specific Terms and Conditions.

## B. CONDITIONS APPLICABLE TO THE COMMANDER BUNDLE

The following conditions shall be applicable to the Clients who purchase the COMMANDER Bundle:

## (i) Commercial conditions

- The 3G or 4G connectivity will be provided for a period of 10 years from the date of the activation of the SIM card.
- The SIM card and the accompanying connectivity dongle shall be used only in relation to the COMMANDER Device (i.e. inside the Device) and not for any other purpose. In order to prevent their fraudulent or improper use, WALLBOX may implement any measures, including the deactivation of the 3G or 4G connectivity.

- The myWallbox Business Subscription Plan to the Application will be free of charge during the first 5 years from the date of the activation of the COMMANDER Device.
- The User can activate the myWallbox Business Subscription Plan to the Application by upgrading their current subscription plan to the aforementioned Plan within the Portal. The User will be required to insert a payment method, but no fee shall be charged for the COMMANDER Device from the COMMANDER Bundle.
- The User can change to any other plan at any time, as many times as they want.

#### (ii) Technical conditions

- The SIM card and the accompanying connectivity dongle shall be installed and configured by the installer pursuant to the indications contained in the Installation Guide.
- Whether the COMMANDER Device has actual connectivity or not depends on a series of factors: the specific geographic region (click here to find out which are the supported countries), the deployment of the network operator, the location (e.g. no connectivity in underground parking lots or in rural areas without network coverage) and signal strength.
- The upgrade by the Users of their current subscription plan to the myWallbox Business Subscription Plan to the Application can only be done in <u>countries where Stripe is</u> <u>available</u>. This limitation already applies to myWallbox Users.
